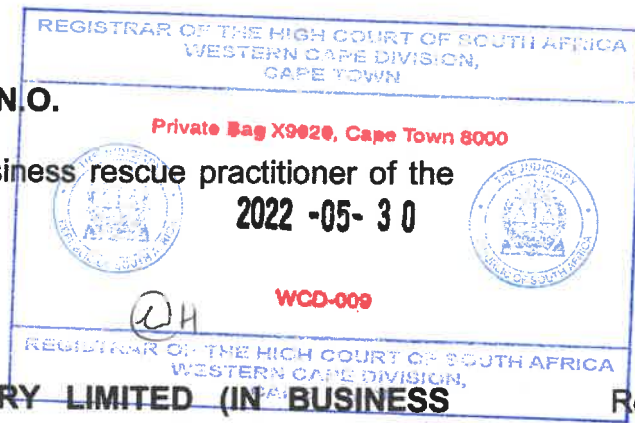

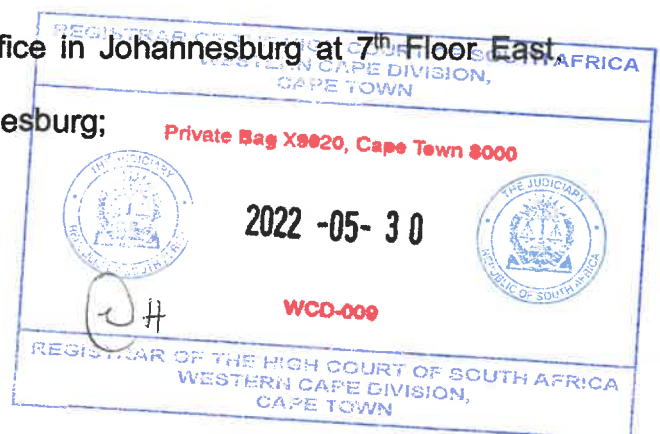

Having heard counsel for the applicant and read the papers filed of record, **IT IS ORDERED THAT:**

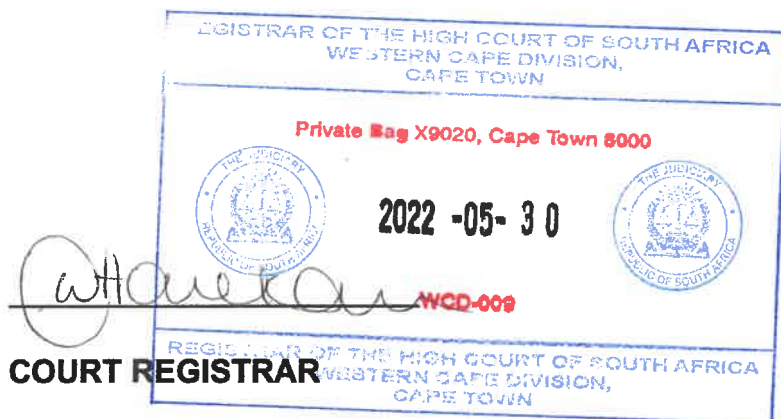
1. The respondent's business rescue proceedings are terminated.

2. The respondent is placed under provisional liquidation.
3. A *rule nisi* is issued calling upon all interested parties to show cause, if any, to the above Honourable Court on **Thursday, 11 August 2022 at 10:00** or so soon thereafter as counsel may be heard:
  - 3.1. why the respondent should not be placed under final liquidation; and
  - 3.2. why the costs of this application should not be costs in the respondent's liquidation.
4. Service of this order will be effected:
  - 4.1. on the respondent at its registered address at Office 103A, Richmond Centre, 174 - 206 Main Road, Plumstead, Western Cape;
  - 4.2. by one publication in each of the *Cape Times* and *Die Burger* newspapers;
  - 4.3. on the South African Revenue Service at 22 Hans Strijdom Avenue, Cape Town;
  - 4.4. on the employees of the respondent based in Cape Town by email and physically at the respondent's office in Johannesburg at 7<sup>th</sup> Floor East, Sami G, Greenvale Road, Johannesburg;



- 4.5. by publication to affected persons of the respondent as contemplated in section 144(3)(a) (employees), section 145(1)(a) (creditors) and section 146(a)(shareholder) of the Companies Act 71 of 2008;
- 4.6. on the website maintained by the Company; and
- 4.7. on Companies and Intellectual Property Commission of South Africa (CIPC) at businessrescue@cipc.co.za and corporatelegalservices@cipc.co.za .
